POLICY DEVELOPMENT & ADVOCACY

The Coalition advocates for funding and policies that support the cleanup and redevelopment needs of underutilized and environmentally impacted land. The Coalition successfully:

- Advocates for federal legislation like, The Brownfields Utilization, Investment and Local Development Act (BUILD Act), that establishes and funds the cleanup and redevelopment of brownfields sites nationwide;
- Supports the improvement of federal environmental liability regulations;
- Produces best in class research that highlights best practices and lessons learned in brownfield redevelopment;
- Convenes national leaders in brownfield cleanup and reuse regularly to increase their expertise, leadership, and relationships on important brownfield policy topics, and;
- Advocates annually for robust federal funding for brownfield programs at both the federal and state levels.

BROWNFIELD COALITION WORKSHOP PROGRAMS

The Coalition offers a series of interactive workshops that help emerging and experienced professionals learn to identify brownfields; learn about federal and state programs governing brownfields; learn about how to move forward with redevelopment from a legal, regulatory, and community engagement standpoint; and learn how to work with private-sector actors to attract development.

The Coalition's workshops are a valuable knowledge transfer tool that takes participants far beyond explaining legislation and to an understanding of how to successfully engage with all actors to transform the land itself.
